## **Dancer / Live Show Performer**

### Interviews and Auditions for these positions start in July.

#### **Primary Responsibilities:**

- Provide a thrilling experience for guests by portraying various role(s) in live performances to interpret character(s), in addition to scaring and interacting with them in scare zones or attractions.
- Learn, rehearse, and memorize scripts and choreography associated with all shows.
- Perform in daytime and evening shows during operating hours.
- Attend <u>ALL</u> rehearsals scheduled for the performances.
- Safely scare guests while maintaining the setting and atmosphere of the zone, attraction, or performance venue.
- Wear and maintain costumes, stage makeup/prosthetics for extended periods of time and appropriately utilize assigned props.
- Maintain cleanliness and safety of attraction, zone, or performance venue.
- Energetically interact with guests and not break character for the duration of the shift.
- Memorize any necessary and/or assigned dialogue, safety spiels, emergency exit plans, safety operating procedures, and park guidelines.
- Make appearances at special park functions or occasionally serve as an usher for entertainment venues.
- Comply with all company and safety guidelines as listed in the employee handbook.
- Other duties as requested.

#### **Minimum Qualifications:**

- Must be at least 16 years of age.
- Must have a positive attitude and strong work ethic.
- Must take direction from the choreographer/supervisor of the performances.
- Must be available for training and/or rehearsals prior to the beginning of Fright Fest.
- Must be able to work flexible schedule including: weekends, late nights, and some weekday evenings.
- Outgoing and team-oriented.
- Must be able to work both indoors and outdoors in all types of weather conditions and in both natural and artificial lighting including Strobes, Fog, Haze, and other technical/special effects.
- Must be alert, attentive and observant. Must be assertive as needed.
- Must be willing and able to interact with Guests on individual level as well as large groups of all ages.
- Must be able to stand and walk for long periods of time, climb stairs, bend, stoop, reach, twist, sit and lift up to 40 lbs.
- Must possess the mental and physical capacities to perform essential job duties.
- Should be a self-starter and able to take direction
- Maintain all SFGE policies and Department Safety Standards
- Excellent communication skills both written and verbal, including large group settings.
- Dance or theatrical background/training preferred.

#### Working Conditions:

Work is performed both indoors and outdoors in all weather conditions. Lighting is both natural and artificial. Equipment used includes radios, microphones, cleaning tools, and technical/special effects. Physical demands include standing, walking, lifting, carrying. Days and hours will vary and will include weekends, evenings and holidays. Position will require close contact with Park Guests.
